Updated messaging for the coronavirus As rates of coronavirus in Norfolk continue to rise, people are being urged to stick to the essentials and follow the national guidelines. A press conference was held today focussing on the following key

messages:

The current restrictions mean that people should only leave home if it is essential:

- To shop for essentials
- To do essential work, because you cannot work from home
- To only carry out essential journeys
- For essential education
- For essential exercise

It's essential – Norfolk must follow Covid restrictions to halt rise in cases. Protect yourselves, protect others, protect west Norfolk

New Coronavirus business support grants available (see attached release)

The application process for the Government's new Local Restrictions Support Grant scheme to support businesses, registered for business rates, that have been forced to close as a result of the second coronavirus lockdown is now open.

Eligible businesses include those who were trading on 4 November 2020 and have been told they must shut by law under the national lockdown rules such as non-essential retail shops, cafes, restaurants and bars as well as hairdressers and beauty salons. Certain businesses remaining open

for Click and Collect or Takeaway services may also be eligible if they have had to close their in-store services.

Businesses can apply online at <u>west-norfolk.gov.uk/businessrateshelp</u> and will need their business rates account number and an up to date bank statement. Depending on whether a business meets the eligibility criteria set by the Government and their rateable value, grants range from £1,334 to £3,000 for the 28-day lockdown period.

To offer some support to those businesses not eligible under the Local Restrictions Support Grant the criteria for another scheme are currently being drawn up. Businesses can express their interest in the Additional Restrictions Support Grant using the form on the business rates help page of the borough council website. More details about this scheme will be published shortly.

This support will be dealt with quickly and efficiently, like the scheme earlier this year which saw nearly $\pm 40,000$ being distributed to over 3,000 businesses. We will be sharing this information with all our contacts, but if you know of any businesses that may be eligible please do share the information with them and encourage them to apply.

Business engagement

We have been working with the College of West Anglia to train some of their uniformed services students to support the business engagement work of the Covid Marshalls and to support other areas of the Covid Marshalls work. Training took place on 19 November and it is hoped that they will be out and about next week. A press release with more detail will be issued shortly.

Engaging with schools and young people

We have been continuing to engage with schools and had a constructive meeting with heads of local secondary schools last week.

We have this week issued posts on Twitter and Facebook that were recorded by members of King's Lynn Town Football Club. The response to these by younger people has been very positive and we appreciate the help of KLTFC for making this happen.

Working with partners

Lily

A reminder that the Lily website is a useful resource for anyone who needs help or support during this lockdown. There is help and advice on there as well as directory of local businesses which are offering a service (click and collect or delivery). If you know of any businesses in your area that are offering a service but not currently listed do encourage them to get in touch. If you are aware of people who need to access these businesses do share the www.asklily.org.uk web address.

Self-Isolating

Self-isolating is crucial in helping to stop the spread of coronavirus. The guidance is:

- If you have COVID-19 symptoms or have received a positive test result you must stay at home and begin to self-isolate for 10 days from when your <u>symptoms</u> start.
- If you live in the same household as someone with COVID-19 you must stay at home for 14 days. The 14-day period starts from the day the first person in your house developed <u>symptoms</u> or, if they do not have symptoms, from the day their test was taken.

In practice, self-isolating requires people to:

- stay at home
- not go to work, school or to public areas
- not use public transport like buses, trains, tubes or taxis
- avoid visitors to your home
- ask friends, local family members or delivery services to carry out errands for you such as getting groceries, medications or other shopping.
